Jon Lanford - Making Allegheny County A Better Place to Live

When governor Ralph Northam announced \$13.4 million in Community Development Block Grants (CDBG) to 14 Virginia counties, Allegheny County Administrator Jon Lanford was pleasantly surprised when \$1.4 million, the highest allocated amount, went toward the Wrightsville Revitalization Project for his County.

“The Community Development Block Grant program continues to be a vital resource for funding projects that help build strong regional economies throughout Virginia and address the most pressing needs in our communities,” said Governor Northam. “The localities receiving these

grant awards are making important investments in infrastructure, housing rehabilitation, and downtown revitalization that will enable them to deliver essential services to their citizens and attract new residents, businesses and visitors.”

Since 1982, the federally-funded CDBG program has been administered by the Virginia Department of Housing and Community Development (DHCD), and Virginia receives approximately \$18.1 million annually for this grant program. CDBG grants are awarded through a competitive process. Most projects benefit low- and moderate-income persons, and many projects are

targeted for the prevention or elimination of dilapidated structures and blighted conditions.

“I was overwhelmed when we received word,” Lanford said of the transaction. “The community leaders deserve the credit for really bringing the community together.”

The Wrightsville Revitalization Project, set for completion in roughly 30 months, will improve housing and other facilities, increase access to water and sewer, and satisfy a multitude of other societal needs.



“We are excited to see the revitalization of such an important historic community,” Lanford said. “Additionally, Wrightsville serves as our front door as people exit off I-64 at the 16...A very important corridor for the Highlands.”

Prior to his nearly four-year tenure as County Administrator, Lanford served Alleghany County as Public Works Director, County Engineer, and Assistant County Administrator. He has also worked in local and State government and in private practice.

As a husband of 20 years and father of two teenage daughters, Lanford’s greatest obstacle is time management, particularly balancing his work and personal life. But his spirited character and appreciation for his community motivate his efforts.

“Local government has the ability to touch so many facets of a community,” Lanford said. “Helping people in our community solve real-life problems is probably the most satisfying aspect.”

As County Administrator, Lanford tackles a variety of obligations. According to Alleghany County’s Official Government Website (co.alleghany.va.us), Lanford coordinates the everyday procedures of the County government, serves as the chief advisor to the Board of Supervisors, and conducts County business in accordance with Board policy, among other responsibilities.

“I enjoy working on initiatives and projects that result in a direct benefit to the quality of life in the communities we serve,” Lanford said. “My desire to serve and an ultra-competitive personality drive me.”

Exercise, sports, and spending time with his family occupy Lanford’s free time. He said he is amazed, blessed, and lucky in his personal and work life, and hopes to continue accelerating success for his County.

Lanford thanked multiple people for their hard work and contributions in helping Alleghany County obtain the \$1.4 million grant, particularly the initiators at Hurt & Proffitt.

H&P Invests in New Trailer for Pipeline Inspections

H&P recently upgraded the CCTV (Closed Circuit TV) equipment by replacing the trailer and mobile office for pipeline inspections. The new trailer has dual axles allowing H&P to inspect pipes over easements in a rougher terrain than the previous trailer could navigate. The office section is a comfortable, climate controlled, cubicle type environment, where the NASSCO trained inspector can perform the pipeline inspections. There is a monitor in the rear of the trailer so that the crew technician and contractor can see “real time” video of the inspection. The new winch within the trailer gives the crew

the flexibility to send the camera farther than ever before, up to 1,500 linear feet through storm and sanitary sewer lines.

H&P has performed TV inspections for municipal clients, developers, engineers, architects and general contractors since 2008. Our crews are certified by the National Association of Sewer Service Companies (NASSCO), the national standard in rating the condition of existing pipe. In addition to mainline inspections, we also inspect sewer service laterals, with the capability of locating the depth to either the main or the lateral.

H&P pipeline inspection cameras have traveled nearly 75,000 linear feet of pipeline in 2019.

We believe our inspection efforts are above the normal pipeline inspection due to our reporting methods. The inspections are managed and supervised by a professional engineer and our reports are given with CADD mapping that help our clients with accurate records at the time of inspection.

In addition to TV inspection work, we also have the ability to provide jetting and root cutting services to clean debris that may be found, and have been certified to seal chimneys in older brick manholes utilizing Flex Seal's Sealing System. Our work has also included inspecting interior building pipes for renovation work or prior to slabs being poured to ensure there isn't any debris or sags in the lines that would pose a costly fix after construction.

H&P cameras will have traveled nearly 75,000 linear feet of pipeline in 2019. Their work is vital to assessing the condition of existing and newly constructed pipes for our clients and the public safety.
